# 11 To Receive Update of the Joint Parish Traffic Initiative

A meeting of the JPTI with Luke Barber from Suffolk Highways, took place at the end of June 2024 and the report can be found on the <u>website</u>

An investigation into the increase in traffic along the B1083 will take place to attempt to ascertain the type of traffic causing the increase.

An informal consultation will take place for the A12 upgrade from Seven Hills to Woods Lane.

### 12 To Discuss Local Traffic Issues

Discussion re the increase in traffic using Wilford Roundabout causing issues such as blocking of the roundabout by motorists coming from Bromeswell. It was resolved these issues will be raised with Suffolk Highways.

### 13 Sutton Residents Entry To Sutton Hoo

There has been an agreement in place since 2004 allowing residents of Sutton Parish free entry to Sutton Hoo. At the time this included Sutton Heath which was part of Sutton Parish.

Sutton Hoo have requested details of the agreement via the Chairman as they have no record. This will be provided before any further discussions take place.

# 14 | To Discuss Local Flooding

The B1083 is still an issue either side of the entrance to Sutton Heath with cars from both directions taking evasive action by driving in the middle of the road. A letter will be sent to Suffolk Highways and the issue will be raised at the local Joint Parish Meeting.
